

Tax-Wise Ways to Make a Difference

2021... Another Especially Good Year to Give

Despite a global pandemic, market volatility and social unrest, individuals are giving significantly to support those most impacted by these unprecedented times.

Here are a few ways to make charitable giving to Sentara Martha Jefferson Hospital and the Martha Jefferson Hospital Foundation part of your holiday season.

Donor-Advised Funds (DAFs)

Many donors who previously have created Donor Advised Funds have increased the dollars granted in 2021 to charitable organizations like SMJH who are on the frontlines of helping those most significantly impacted by COVID-19.

Retirement Assets/Charitable IRA Rollover Gifts

Popular every year, individuals at least age 70½ are allowed to make direct transfers — referred to as QCDs (qualified charitable distributions), from their individual retirement account (IRA). These distributions of up to \$100,000 per year may be made to a qualified charity such as SMJH without having to include the transfer as income for federal tax purposes, which avoids bracket increases and other negative consequences. Because you already deducted or avoided tax on these assets, there is no additional charitable deduction, but the QCD also counts toward your required minimum distributions (RMDs are required at age 72 now).

Gifts of Appreciated Securities

If you have held stocks for more than one year, you may gift shares to Martha Jefferson Hospital, avoid paying capital gains tax and possibly take a tax deduction for the current fair market value of those securities (up to 30% of your adjusted gross income).

Cash Gifts Treated More Favorably for 2021

In response to the overwhelming impacts of the COVID-19 pandemic, Congress passed the Coronavirus Aid, Relief and Economic Security Act (CARES Act). Among the provisions designed to assist those negatively affected and to encourage charitable giving that were extended for 2021:

- Donors can receive a charitable tax deduction of up to \$300 (married couples up to \$600) on their 2021 taxes, even without itemizing.
- Donors who itemize may deduct up to 100% of their adjusted gross income for gifts of cash made in 2021 — an increase from the normal 60% limit. Donations in excess of these percentages may be carried forward for five successive years.
